#### **CEO of Stand Up Against Sex-Trafficking Of Minors**

Hello, My name is Jin-Kyeong Cho, CEO of Stand Up Against Sex-Trafficking Of Minors.

Established in 2012, Stand Up Against Sex-Trafficking Of Minors is a non-profit private organization with expertise in two special fields: sexual exploitation & children and adolescents. Our center has established a system from the ground up to aid holistic support for children and adolescents who have been victims of sexual exploitation, which the system used to be segmented and superficial, from discovery to prevention, victim support, healing, and self-reliance. Our Center finds victims through various channels, such as online counseling, provides professional support pursuant to the victim's situation and needs while conducting counseling. Experts such as doctors, psychotherapists, and lawyers from the center's legal, medical, and psychological support groups are matched 1:1 with sexually exploited children and adolescents to provide professional support in special areas. The human community of the Legal, Medical, and Psychological Support Group, which is formed every year in the form of recruitment, is a strong support force for Center's activities such as improving awareness of Korean society. After its professional support, self-reliance, self-sufficiency, and livelihood support are continued to improve the quality of life of the victims and lead to prevent re-victimization of sexual exploitation. Victimized children and adolescents, who are most often involved in sexual exploitation due to the absence of social capital and safety net, are highly likely to be flown into the sexual exploitation market if they are not linked to real life livelihood support. Thus, our center connects them to shelters to resolve their housing problems, supports them to extend their studies, and supports them to the end until they are fully settled in order for them to become fully independent as healthy members of society by mainly linking them with support organizations of employment. As of 2021, we have till now supported about 30,000 cases of counseling for 20,000 sexually exploited children and adolescents, and have trained a total of 30 cyber peer counselors (direct counselors).

"Stand Up Against Sex-Trafficking Of Minors (aka TeenUp)" established an integrated support system to protect and support children and adolescents who were used for sexual exploitation crimes, and filed complaints against sites that lure/arrange sex trafficking online, smartphone chat applications, and sexual exploitation criminals. In addition, TeenUp, by supporting children and adolescents with intellectual disabilities who were used for sexual exploitation, revealed current Korean society's problems, and reported the crimes and punishment of sexual exploitation by police officers who were supposed to support victims.

In this way, TeenUp carried out activities to urge changes in Korean social awareness, legislation, policy proposals, and support systems, and as a result, the 「Act on the Protection of Children and Youth Against Sex Offenses」 was revised in 2020.

TeenUp will continue to do everything possible to prevent the crime of sexual exploitation. For this purpose, our center will work in unity with the world to eradicate sexual exploitation, and for our next goal, we will establish an Asian network and information center within TeenUp. We are sure that our activities will be a step towards making the world a better place.

- Integrated support center for preventing children/adolescents/internet/sexual exploitation



#### **Support Group**

#### Legal Support Group

- Composed of more than 50 lawyers
- Legal support for victims of sexual exploitation of children and adolescents, legislative activity to improve relevant law, systems & policies, activities to change social consciousness (conferences, debates, press conferences, etc.)

#### Psychological Support Group

- Composed of professional psychotherapists using various mediations such as art therapy, movement therapy, and drama therapy
- Based on the characteristics of children and adolescents who find it difficult to open up and express themselves, give support for treatment of complex post-traumatic stress disorder caused by sexual exploitation; and also give 1:1 psychological counseling for caregivers

#### Medical Support Group

- Composed of doctors in specialized fields such as psychiatry, obstetrics and gynecology, and internal medicine
- Medical support for physical and mental illness for children and adolescents who have been victims of sexual exploitation

<Digital Sexual Exploitation (prostitution, etc.) crime evolution process>




As the crime evolution process as seen above, this also means deepening process of victims injury

- 1. Digital sexual exploitation is a crime that develops seriously along the same line. There is a series of processes that continue u ntil a victim is used for sex trafficking. Here, sex trafficking and sexual violence are sometimes difficult to separate. At this point, victims of sexual violence are sometimes recruited into sex trafficking, and are also sexually assaulted in forced sex trafficking arrangements.
- 2. In Korean society, neither sexual violence nor sex trafficking is recognized as damageunless assault or confinement is clearly revealed. In effect, the victim must prove herself the facts of why the victim did not act voluntarily. Even in the case of sex trafficking, although it is at the most serious stage in the process of evolution of the crime and the deepening of the damage of the victims, the victims are separated between voluntarily and forcibly, and between victims and crime participants.
- 3. The crime of sexual exploitation using digital media occurs primarily digitally, and as a crime that manipulates victims through personal information, violence or confinement is invisible. For this reason, investigators believe that the victims became partners in the crime voluntarily rather than coercion.
- 4. Korean society criticizes, stigmatizes, isolates, and punishes victims who are in the most serious stage of violence. In the end, this only results in the safest protection of the offender.

We provide professional and systematic integrated support for recovery of daily life damage through education, from discovery of victims of sexual exploitation (prostitution, digital sex crimes, etc.) to prevention, legal, medical, and psychological support.


#### **Connection with Emergency Rescue and Supp ort Services**

- Prompt emergency rescue through cooperation with investigative agencies when exposed to risks of on/offline sexual exploitation (prostitution, digital sex crimes, etc.)
- Prevention of re-damage to victims through linkage with various institutions tailored to the needs and circumstances of children and adolescents

#### **Professional Counselor Attendance Support Project**

When investigating children and adolescents who are victims of sexual exploitation through the
establishment of a hotline with investigative agencies, a professional counselor is present from the
initial investigation in the investigative agency to prevent, protect, and assist in secondary damage
so that the victims could be safely investigated

#### Direct Support such as Legal, Medical, and Psychological Support



#### Medical support :

Health checkup with a medical questionnaire  $\rightarrow$  Accompaniment to each medical department  $\rightarrow$  Continuous treatment support  $\rightarrow$  Conduct examinations if necessary
